The **IFIP Working Group 11.8 - Information Security Education** will hold the 18th World Conference on Information Security Education (WISE2026) to advance the state of computer security and information assurance education throughout the world. To that end, we invite practitioners, researchers, policy makers, and others from academia, industry, and government to submit papers for presentation and topics for working group discussions to WISE2026. We will organize the conference around paper presentations and potential working group topics. All presentations and discussions will be in English.

The conference will feature general paper sessions and a working group session.

- **Paper submissions** should follow the guidelines for full paper submission using the template that can be found at <https://www.ifiptc11.org/wg118-wise#authors-guideline>. Submit papers at <https://easychair.org/conferences/?conf=wise2026>. The submissions for WISE2026 will be reviewed separately from IFIP SEC. Papers must be original work, not previously published, written in English, and at most 14 pages long including references and appendices. All submissions will be reviewed double blind and must be submitted in a blinded version (author and institution information removed). Submission instructions are available on the conference website. Acceptance will be based upon originality, contribution to the field, and relevance to the conference. Accepted papers will be published in the WISE2026 conference proceedings under the *IFIP Advances in Information and Communication Technology Series* by Springer (with ISBN and indexed in Scopus) and distributed at the conference.
- **Submissions for working group topics** should describe in no more than 500 words the topic of the working group, its relevance to IFIP TC11 WG11.8, the goals to be achieved during WISE, and the plans for continued collaboration after WISE.
